



CIRCULAR LETTER N° **0347** 2023 TO
INFORM ABOUT THE PARTNERSHIP BETWEEN THE GOVERNMENT
OF THE CENTRAL AFRICAN REPUBLIC AND K-POLYGONE CA INC

This circular letter is to inform that the Central African Republic has signed a contract with K-POLYGONE for the issuance of Electronic Slips for monitoring land, sea and air traffic for a better control of the freight generated by its foreign trade. This is the issuance of documents for the accompaniment of goods (bulk, conventional, containers, new and used vehicles) to or in transit through the Central African Republic.

TO THIS END:

Article 1:

All carriers and operators involved in the transport of goods in transit through the Central African Republic must comply with all the requirements of the Electronic Tracking Slips set up by the Central African Republic. Here is the contact information for the mandatary:

Article 2:

We inform all transport companies of the following provisions to apply. All required documents and confirmations related to the issuance must be validated by the Technical Partner.

- Scanned copy of the shipment manifest and a detailed description of the cargo
- Scanned copy of commercial invoice

Article 3: Rates

Transport companies must ensure that fees are paid to K-POLYgone duly authorized for the collection of these charges.

Monitoring and control of the operations of any goods, regardless of the mode of embarkation, unloaded and/or loaded in CAR. ECTN collection network at boarding, fee schedule applicable from the date of signature

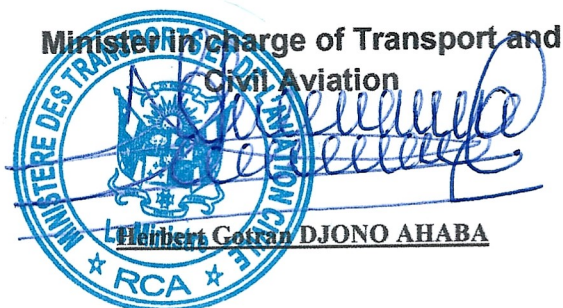

Article 4: Sanctions

The entities concerned are required to ensure the strict application of this circular letter. With regard to import, any goods not covered by an ECTN upon arrival in the CAR will be subject to a fine equivalent to ten times the value of the ECTN normally due under the tariff in force.
